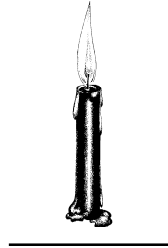
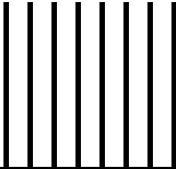

I talked about Intel's 810 chipset a couple months ago? There's more. I heard that in an 810 hardware-support forum on Intel's Web site, an Intel engineer said: "The RTC (Real Time Clock) may inaccurately report that the clock is not busy when it is actually in the process of updating internal registers. This may result in invalid data being read in the date and time fields of the RTC, but the erratum does not modify the actual RTC values." It wouldn't hurt to look for a software work-around if you have that chipset.

Intel's new 820 (Camino) chipsets are also controversial at this point. With the introduction of Direct Rambus in three different speeds, 600/700/800 MHz, the 820 will be in two different formats. One supports all three speeds while the other supports only two. They support PC100 SDRAM, but not the more popular PC133 SDRAM, which amounts to a clock-speed mismatch.

Intel is using a new technology called the "Memory Translator Hub" to connect if you are using PC100 SDRAM. What a saga! If I were you, I'd check the net for more information if you are looking into motherboards, or check with knowledgeable people in your user group. There is much more but I'll let you check all that out. Last I heard Intel had the 820 chipset on indefinite hold which leaves many OEM people frustrated.

Get Better At Windows 98

I've been browsing a new O'Reilly book called "Windows 98 in a Nutshell" and I like it. It contains 618 pages packed with information about using Windows 98. I had no problem understanding it all, nor the sequences to use its information. I took a cursory look, but I certainly learned a lot while browsing through it. Even several new keystrokes. It is an O'Reilly book written by Tim O'Reilly, Troy Mott & Walter Glenn.

Talk is Cheap

Thanks to Dennis Adamson, a member of my club, for alerting me to this one. Do you use phone cards? First time I used one, I was dismayed to find that my time started when I made initial contact to their access number. By the time I made contact with my wife, the voice said I had used seven minutes. The following was not meant to replace long distance service on the home phone, but to serve as an electronic phone card. Even so, a couple folks I know are using it at home with their speed dialers.

Take a look on the Web at <<http://www.BigZoo.com>> and see if you aren't impressed. They offer long distance service anywhere in the continental US for 3.9 cents per minute. You read correctly, 3.9 cents per minute. Even the service to other countries is priced right. Looking at the foreign country rates was very interesting.

There may be a 55-cent connection fee from a pay phone, according to their Web site, but that's not bad. I get charged 75 cents each time with my AT&T card, plus a monthly fee. I didn't see any monthly fees for using BigZoo. Check it out. You sign up on the Web and replenish your time using a Visa or Mastercard. You start with amounts as small as \$10.00.

Home Automation? Anything You Want

I received a catalog called "Smarthome.com" and it seems to have just about everything to automate your home. Prices in this catalog are nothing special, but I liked the selection. I wouldn't have worried

about passing this information on, but it even offers one of the best toys I ever bought. I have mentioned my automated drapery rod to others who also wanted to buy it after hearing about it, but it can only be bought through retailers, mostly overpriced catalogs. This is for those people. I tried in the past to get the Boss Company to give me a deal, but they were reluctant for fear of offending their retailers.

The "Boss" drapery rod control can be added to your existing drapery rod by cutting the cord and splicing in the chain provided. Mine lets me program up to six movements a day with stops wherever I want them. I didn't buy a remote, but one is also available. I have loved mine ever since the day I installed it. I bought mine at a CES show. The movement of your drapes each day makes it look like someone is home when you are away. The catalog price for the basic drape controller is \$169.95. No "deal," but not that bad.

The phone number for the "Smarthome.com" catalog is 1-800-762-7846. Guess what their Web site is! If nothing else, you'll enjoy the catalog. It sure has a variety of products.

Sheet Music To MIDI File

Own sheet music you would like to hear without playing it? You need a scanner for this, but here is the description for this fascinating software: SharpEye Music Reader can convert a scanned image of printed sheet Music (a TIFF or BMP file) into a MIDI file. It incorporates a music editor that displays the converted image in standard music notation. You can also correct errors before saving

as a MIDI file. The music editor is linked to a display of the scanned image to facilitate the checking and correcting of the notes. It can deal with multiple staves per system, multiple voices per stave and recognizes most common musical symbols, including lyrics.

This fascinated me and I hope many of my musically inclined readers, so I have worked out a deal with Graham Jones, the developer. Go to the Web site <<http://www.visiv.co.uk/download.htm>> for a better description and to download a 1.1 MB self-extracting fully working evaluation software.

If you like what it does, you can then contact BMT Micro at <<https://secure.bmtmicro.com/ECommerce-OnSite/48101.html>> to purchase the registration key for \$35.00 (normally \$50.00). That URL was created just for this deal. Your registration key will be e-mailed back to you within 24 hours. You then enter the registration key into a box in the program's "help." Since the author is in Scotland, ordering is complicated because of foreign funds, but BMT Micro is a US organization for ordering. More information can be found at <<http://www.visiv.co.uk>>. If you desire it on a disk, call BMT Micro at 1-800-414-4268 to order, or if you have problems with this URL.

I have not tried this product myself as yet.

It's The Internet Calling

Here's a product to save money on your phone bill. Users get low-cost functionality and flexibility for phone calls over the Internet. ACS Innovations has introduced the new Ezfone Pro. With the \$129.00 (SRP) Ezfone

PC add-in card, individual and SOHO firms can use the Internet to call anywhere at only the cost of a local call.

The board allows you to forward calls to an alternate location and provides accessibility when you're away from the office. The Ezfone Internet Telephony product provides people with the mobile solution for international communications with just the local Internet connection charge.

My box contained two ISA adapter boards w/40 MIPS digital signal processing for audio compression (full duplex audio), two installation disks, two manuals and two phone cords, so both you and the remote party have everything needed. The manual has step-by-step instructions with pictures showing the PnP wizard. You will need dial-up networking, an ISP, Internet TCP/IP connection, 486 or better processor, a free ISA slot, touch-tone telephone, 14.4 Kbps or better modem and Windows 95/98 OS. Use either a touch-tone telephone or a microphone and speaker connected to the Ezfone card.

The called party should be connected to the Internet by previous arrangement. Otherwise, a short call must be made to set up the Ezfone call, or make initial contact. Imagine the savings, especially for International calling. Also works with others using Net Meeting or ICQ.

Discount to user group members is 20% off the \$129.00 list. Please order 3-5 at a time with a single shipping address and single payment to avoid S&H. The order should be identified with the user group organization, and referencing the user group discount of 20%. Call CT & R Inc. at 1-408-566-0900 (fax 1-408-566-0909) and talk to

Michael Ho to order. Check their Web site <www.acscompro.com>. If you must order an individual piece, there is a \$20 S&H.

LPWA: THE POWER TO SURF INVISIBLY

I have the power to cloud men's minds.

In radio days, devouring Lamont Cranston's adventures as the Shadow, I lusted after the secret mantle of invisibility. Little did I know that it would be the Internet that would make this ineffable power necessary, and that I would wrest it from the Internet itself. Neither new nor secret, this power bubbled up from the primal ooze in the ancient days of Internet time—1997. I will indoctrinate you into the cult.

The World Wide Web hosts an unwelcome spider: a potential for considerable compromise of your privacy. Many web sites want to know your name, age, snail-mail/e-mail address, interests, income, what other sites you visit. For starters.

You may not care if the Crummy Cookie Company or Wacky Web Bookstore collects such info from you for marketing purposes. But what if you visit sites that betray your interest in, for example, treatments for a

particular disease? What if that information is collated so as to identify you, and passed on, purposely or inadvertently, to employers, insurance companies, governments or other snoops who might use it in ways you would rather they didn't?

Like the banker on the Maryland health commission who used state computers to match cancer patients to bank customers, and canceled their loans. (Time, Aug. 25, 1997)

Surfing generally reveals largely insignificant information about you: your ISP, the number assigned to you (which changes on every call), which browser and operating system you use. To get the goods on you, many web sites induce you to register in order to enter or fully utilize their pages. Registration information, if combined with the other details, may enable tracking of your web activities. Many sites place "cookies" on your drive, which are returned to the sites on future visits.

You needn't, of course, enter personal info if you don't wish to, and you can turn cookies off in your browser. But this may keep you from some interesting sites. The New York Times, for example, won't permit access unless you accept their cookie. Many vendors use cookies as the basis of their online purchase systems.

Perhaps the biggest Internet annoyance is junk e-mail, known as "spam." Software developers, Internet pundits and legislators struggle to discover methods of defeating spam. Lucent's Personalized Web Assistant can make you invisible to most would-be privacy invaders and subvert spammers who don't already have your address.

LPWA is free. You needn't download any software. It asks no questions beyond your real e-mail address and password. Merely edit your browser preferences with the simple instructions at <www.lpwa.com>, and login for each browsing session. Then for each new web site registration enter your username, password and e-mail address as a backslash followed by "u," "p" and "@" respectively. LPWA translates these into random letters/numbers, consistent for each login at each site, but different for different sites.

If a site e-mails you, LPWA forwards it to you anonymously.

Even if you care naught about anonymity, you'll save energy: you type only two keystrokes per login line, and you needn't remember passwords/usernames. Widely used, LPWA's target-revokable e-mail addresses could castrate spam. Combine LPWA with general anonymizers (<www.anonymizer.com>; <www.cyberarmy.com>) and you're all but invisible.

Don't surf naked. Cloak yourself in translucency.

Adventures in Postageland

My husband has a business that incurs huge postage bills, but a profit margin that really doesn't justify a postage metering system. Even the smallest Pitney-Bowes machine costs \$25 a month, over and above actual postage costs.

New postage systems have started to appear, but most will print only to plain envelopes and require you to be connected to their Internet server in order to print. Additionally, you have to supply the mailing address to them so that they can verify the 9-digit zip code for printing. Call me paranoid, but I don't want someone having access to my mailing list.

Neopost, in partnership with Staples Office Supply Co., released their **Simply Postage** system earlier this year, but until recently it was Windows only. Their Mac version started shipping on November 1st. Simply Postage prints to labels, ships with its own meter/thermal printer and scale, and handles standard First Class, Priority and Express mailing. The standard cost is \$17.95 a month, plus postage and a \$5 charge each time you add postage to your meter. Because I ordered early, I was offered the service for \$9.95 a month with a guarantee of no future price increases. The initial cost is \$49.95, but includes your first \$50.00 in postage.

The software is well designed and very Mac-friendly. System requirements include Power PC, 16 megs RAM, OS 8.0 or later, serial or USB port, and modem, cable modem, DSL connection, ISDN line or T-1 line. For once, we are ahead of the Windows platform. Theirs will only work with a regular modem and serial port. The meter and scale housings are clear and Bondi blue, with extra covers in the rest of the iMac flavors. The meter has a serial port on it, but comes bundled with a Bondi blue Entrega serial-to-USB converter. The scale will handle packages up to 4 pounds.

The fun started with the initial

order. I had emailed for information twice, in July and again in September. As a result, two sales reps called in early October. I told the second one that I had already ordered it the day before. Several days later, another person called to get our address and billing info that the first person had been given, but somehow the "computer" couldn't find. Fine. On October 22, I received another call saying that the system would ship either the 21st or the 22nd. The next day, call #5 came asking for information for our USPS license from the Post Office. I admit that I was less than cordial, seeing as I had already given this information to callers 1, 2 and 3. Caller #5 and his supervisor both assured me that the system had shipped on the 21st. Wrong!

By the 27th, the package had not arrived, and with the repeated calls for information, I decided to check to be sure that it had been shipped to the right address. "Gee, sorry. There was a problem and it will ship on the 28th or the 29th." Yep! Sure! And the Pope is really a blonde stripper from Vegas. Want to buy a bride? On November 2nd I called again and was told first that there was a software problem, then there were shipping problems and that while they hoped to ship that week, they were through making promises. Thank you! I informed them that I would definitely be reviewing their product and service for two large user groups. Two days later, the system showed up. Express mail, no less.

Connecting it was a snap, although I'm forced to use the serial connection with my A-B switchbox. It works beautifully with the Entrega serial-USB converter and the USB PCI card

that I installed in my 6500 last month, however the converter refuses to coexist with a StyleWriter 2500 connected to the printer port. I can print as long as I haven't accessed the postage meter. After I've launched the postage software, the Print command tries to funnel the print files to the postage meter instead of the StyleWriter. Don't know if this will happen with other serial-USB converters, but I intend to find out. While the switchbox does the trick, it would be nice to be able to use the USB card and not have to constantly switch back and forth.

I dutifully filled out the form required to download my first \$50 in postage, faxed it back to the proper number, then proceeded to wait for confirmation that I could now start downloading and print some postage. By the next morning, not only had I not received word back, checking my account status on their website showed a \$17.95 charge from the day before, with no further information. There was no data regarding what had been charged. My guess is that it was an automatic monthly charge, but it should only have been for \$9.95 and the first month was to be free. Another call to customer service. The service rep I spoke with was stumped by the charge, as she couldn't access any invoice with the given number. We'll see what the credit card statement says! As to the missing postage, she wasn't sure what the problem was, but promised to find the answers and call me back. Seven hours later I was back on the phone.

This customer service rep couldn't understand why I was upset, as the mystery invoice didn't exist, even if it

was showing on the website. I'm sure the attitude would be different if his credit card was the one involved. He finally put me on hold for 10 minutes, and I ended up back with the rep from the morning session. She said the mystery invoice did not exist and my postage would be available as soon as the other guy could get to it. As it was by now late Friday afternoon and they don't work on weekends, I asked if it would be today or would I have to wait until sometime next week. (I know, I know, I'm a bit***) She put me back on hold and came back a couple of minutes later to say that it was a done deal and I could now access postage. She offered to talk me through the download, but I told her it would be rather difficult as there is only one phone line in my office. My husband who won't touch a computer has two phone lines in his office, but that's on the other side of the house.

I hung up, then dialed in to my ISP and tried to download, finally. Forget about it! A message box came up that said "An error occurred while purchasing postage. Failed to retrieve information from server." Oh, joy! Tried it again going through my backup ISP. Well, instead of calling Customer Service again, I decided to go straight to Tech Support. They had to be better, right? Wrong again. The only one who knew anything about Macs was on his dinner break. They promised FAITHFULLY to have him call back, ASAP. Here we go again! By closing time I still hadn't had a callback, so I emailed both Tech Support and the parent company, Neopost.

On Monday afternoon I received a call from one of the supervisors,

checking to make sure I had finally been able to download some postage. I gave her my version of the events. She said that they had upgraded the server software on Friday, and that was probably the reason I'd had problems. When I told her that I had received the same error message that morning, she was stumped and promised to find out what was going on and call me back within 30 minutes. Can you say "Empty promise?" I did get a call from tech support some six-and-a-half hours later, but I had gone out for a while. I returned the call and ended up with a voice mail system, but no humans and no return call by close of business.

After business hours on Monday, I emailed the Monday morning supervisor, indicating my frustration and dissatisfaction. As I mailed it, I received an email from someone in Tech Support saying that the server had been down for the weekend, so try it again. Replied with the usual been there, done that.

Late Tuesday afternoon I received a call from their one and only Mac expert, a very nice fellow by the name of Ernest. He was stumped, but was working with one of the programmers to see if they could figure out what was going on. Other Mac users were getting the same error message. After going over my setup and everything I had tried including the IP address of their web server, Ernest suggested that I try a third server address, a difference of one digit. It worked! We have postage!

The software is well designed. It looks like it was designed by Mac programmers and not just ported over from Windows. You can program the

printer to produce a default stamp, so that you can print individual stamps at the press of a single button without accessing the software. Using the software, the scale will weigh your envelope or package and give you the proper postage for First Class, Priority or Express Mail. Enter the destination Zip Code and it will also print the proper bar code information. You can also tell it to print up to ten stamps at a time and date the stamps up to a week in advance.

Even after all the frustration and headaches, I really like the system. I've even volunteered to be a guinea pig for future software testing and troubleshooting. I hope the brass at Neopost appreciate Ernest. If he had displayed the same attitude as other Neopost employees, the system would have gone back. As it is, I have his direct phone number and extension and I will keep it handy.

Castlewood Orb Update

Those with Castlewood ORB drives for Mac have patiently waited for the release of the promised tools application that was to have been bundled with it. In the last few weeks, Castlewood has release several versions of a limited tools application that only formats and mounts the disks. Unfortunately, it has been less than perfect, and in some cases caused damage. While the latest version seems to be alright, I can't quite trust it.

At the same time, Castlewood has licensed MacMedic to distribute a limited version of their MacMedic Tools that will work only with ORB drives. The MacMedic ORB Tools can repair, defrag, recover damaged files, do backups, and can format your ORB disks to HFS+ without data loss. The best part is that it is entirely free. All you have to do is register on their website with your ORB serial number. They will then send you a password to unlock the downloadable file. Yes, you do have to put up with a splash screen that touts the full version of MacMedic, but we can live with that.

Boolean queries. Some try to translate the queries properly, but if it cannot it will drop the unrecognized items. This will produce the opposite of what you want in the case of NOT.

Others query the search engines one at a time, producing quicker results, but also return duplicates if more than one search engine returns the same site. The last site visited was a meta-meta-search engine that queried meta-search engines.

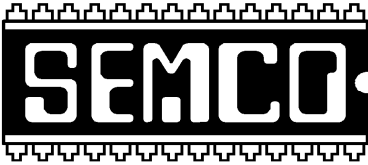

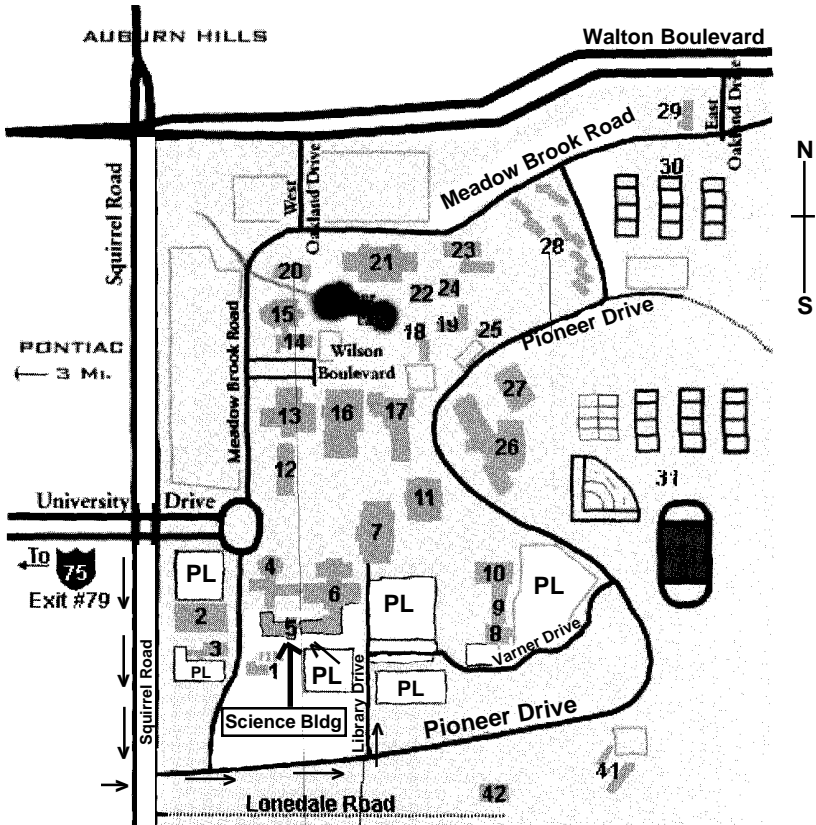
