#### [April Deals Column:]

I finally received the necessary data to prepare and file my 2009 federal income tax. I had download TaxAct when it was only \$12.95 in preparation. I entered the data and when the program computed my taxes, I printed the pages to study them. It showed I was only paying a small income tax and would get back most of the withholding taxes as a refund. My return was relatively simple with five W2s, three 1099s for interest received, and two 1099s for dividends received, neither of which amounted to much this year.

I also had a capital loss for the almost worthless GM stock I sold and I also had insulation installed in our attic which was deductible. The fact that I would be getting back almost all of the money that I paid in made me suspicious. I've always had excellent results using TaxAct in previous years, but getting most of my money back didn't look right. I decided to do it all over again with another free tax product, to compare results.

I decided to try the popular free Turbo Tax to double check. It's done right online. I studied my way through it and found some interesting features; and a few confusing items. When I was almost finished. I discovered that the free Turbo Tax would not handle a capital stock loss transaction unless you paid \$14.95 for its other features, (I may have missed something in it). However, it did ask for information about loss carry forwards from my '08 tax return (naming the line numbers) and I could probably use that part by substituting some figures to accomplish what I wanted to know. I tried it and ended up with a result that was somewhat different than I expected, but I thought "it was possible it could be right and maybe TaxAct was wrong." I liked Turbo Tax, although the W2 importing feature didn't work for me in either of the free products I tried.

After considering my valuable time, I decided to try a free tax preparation program from the IRS Web site. There were many free ones listed there, but only four worked for Florida Residents. I choose one called "Complete Tax" and had to do that one on line. I entered the data and it was continuously computing and showing my refund as I entered the data, with a few wild refund numbers. This one allowed my capital loss transaction and asked for loss carry forwards, but when I was done; my refund was more than I had paid in. I rechecked it and found several insignificant omissions, but had to do trial and error to see if they fixed anything. Some were places I hadn't put a check mark for the page being finished, and two were minor data errors.

After an hour of checking and rechecking numbers and check marks, it finally showed a refund that was within \$20 of what TaxAct had come up with. Again, I rechecked most of the figures in both programs. I was unable to figure out how to get Turbo Tax to print the pages, or even look at them on the screen, which made comparisons tough. However, Complete Tax did let me print the return and I could easily study the printed pages from Tax Act and Complete Tax to compare numbers. I was finally convinced I could submit the Tax Act return after I input the \$250 Stimulus checks I had originally missed. Complete Tax had easily shown me I should enter our stimulus checks which I missed in the other two I had to call Tax Act tech support to find where

to make that entry, but they answered immediately and walked me through it quickly. They have great tech support.

It's been submitted and the refund should be here in ten days, unless the IRS finds fault with my work. Tax Act did its job again and I'm happy, although Complete Tax was good. I'm already considering what to do with the funds. Spending it seems like a good idea to help the economy. Maybe I'll call the cruise line!

This article is partly inspired by the recent release of OpenOffice.org v3.2.0.

Microsoft Office (MSO) and OpenOffice.org (OO.o) are roughly equivalent—like MS Office, OpenOffice. org is a suite of applications. The main parts of each suite are similar: a word processor (MS Word vs. OpenOffice. org Writer), a spreadsheet (MS Excel vs. OpenOffice.org Calc), and presentation software (MS PowerPoint vs. OpenOffice.org Impress). The difference? OpenOffice.org is free of cost and open source software— MS Office is neither free nor open. OpenOffice.org is also cross-platform-versions are available for Windows, Linux, Mac OSX, and others See the end of the article for download links.

One has to wonder why school systems (especially those in low-income areas) continue to teach Microsoft Word or Microsoft Office. Many students' families may have problems being able to afford MS Office packages costing between \$100 and \$350 (or more). For these users (and most others) a free equivalent like OpenOffice.org begins to look pretty good. To a considerable extent, once you have learned any word processor, that knowledge is useful for any similar program. In fact, most Windows-using beginners would be well-served by starting with the WordPad application included with Windows and working up from thereespecially when differences between the different versions of MS Office are taken into account.

Part of the problem in changing teaching tactics on the part of teachers and school systems is training and habit, but much of the issue is probably one of simple familiarity-or is it so simple? In the early days of computer word processing, one of the issues in moving to newer or different software was sometimes referred to as baby duck syndrome, though this might just be a fancy name for "inertia." Another issue is compatibility; how can users be sure that a document saved in OpenOffice. org Writer will look the same in MS Word? This article will try to address some of these issues Even those users wishing to stick entirely to MS Word or MS Office may be able to glean some useful information here.

The Microsoft Office suite is proprietary software. This also means that the default file formats it usually

uses (.doc, .xls, and .pps) do not have published specifications; thus, thirdparty software must reverse engineer these file formats in order to read and display those files correctly-the MScompatibility part of the OpenOffice. org suite is one example of software built this way. This process is made much more difficult by the changes to the MS-proprietary formats over time-a DOC file created by Word XP has a substantially different internal format than one created by Word 6.0 or WordPad. To complicate matters further, MS Office 2007 uses new default formats- .docx, .xlsx, and .ppsx-that require additional software to be read by Microsoft's own free viewers or older versions of Office. The needed software is free, but still...

The OpenOffice.org suite, on the other hand, uses default file formats that are open, with published specifications collectively known as ODF (Open Document Format)—but users can change those defaults. For those users running OpenOffice.org Writer under Windows, I often recommend changing the default Save formats to those used by MS Office—with some cautions. Most of the following discussion addresses word processor DOC files; OO.o v3.2 can load DOCX files as well.

One aspect to be concerned about is the possibility that a DOC file created using OpenOffice.org Writer may render slightly differently when displayed in Word. This is one reason why I recommend that Windows users who install the OpenOffice. org suite should also install the freeto-use Microsoft Office viewers for Word, Excel, and PowerPoint. They are useful not only for cross-checking an MS-formatted file's compatibility with the MS software suite but also useful because opening a file in the Word viewer (for example) is much less resource intensive than opening a full word-processing application to do the same thing—not to mention the fact that you can't edit the file by accident in the viewer (accidental editing has happened to me, with annoying consequences).

Another way that the MS Word viewer can be used is to load a DOC file, then copy-and-paste the content into Writer for editing. This sometimes works better for certain types of formatting than loading the file directly into Writer. This may also be true for some DOCX-formatted files, though OpenOffice.org v3.2 imports most DOC and DOCX files just fine.

I personally leave the OpenOffice. org default formats as they are. As I work on a file, I find that it's better to leave them in the default ODF formats—but once I'm finished with it, I will save it in an MS-compatible format as needed. If I can, I use RTF (rich-text format) because it's the most compatible across platforms, but I will use the DOC format if necessary for more complex documents.

If a user wants to change the OpenOffice.org default Save formats, it's fairly easy–Just save as "ODF Text Document.":

Under the Tools menu, select Options. Click the box next to Load/ Save to open the submenu. Within the General dialog box you will find various settings. The ones we are most interested in right now are the Document type and Always save as drop-down menus. Here you can change the default save formats to Microsoft Word 97/200/XP formats. Do this for Text, Spreadsheet, and Presentation. You are now good to go. There are also conversion options within the Microsoft Office part of the menu, but you shouldn't need to go there.

In short, OpenOffice.org v3.2 seems to be a winner, so far— it's the most MS Office-compatible version yet. There are a number of tutorials available on the Internet, as well as a variety of useful books available on the subject. It should also be mentioned that there is yet another alternative to MS Word: AbiWord. I'm not going to discuss that program here, except to say that it's a good word processor that may be especially useful for older PCs with limited memory or limited hard drive space.

#### Internet Speed Tests By Warner Mach

The FCC is initiating an effort to bring high-speed broadband to all areas of the country. In conjunction with this effort they are providing a web site: <<u>http://</u>www.broadband.gov>.

It is possible to go to this web site and determine your Internet speed. The FCC also asks for your mailing address. This information is being collected in order to determine the broadband speeds in various areas.

Our former newsletter editor, Bill Agnew, reported in the March 2007 issue of the DATA BUS the efforts of his New Mexico group to compare the speeds of various ISPs. See: <<u>http://www.semco.</u> org/newsletter/DataBus200703.pdf>. It appears that the facility they were using for testing is no longer available.

The FCC has two "beta" programs they are using for testing: (1) Ookla and (2) M-Llab. I ran tests using my machine under the following: (1) Verizon Wireless card. (2) Wi-Fi at Panera Bread (Westland Mall location). (3) Wi-Fi at the Westland Library–I indicate the times since speed can vary with time of day:

The measures are defined as follows at the web site:

\* Download Speed: The speed at which data is sent from the testing server to your computer.

\* Upload Speed: The speed at which data is sent from your computer to the testing server.

\* Latency: The time it takes for data to be sent from your computer to the testing server and back (the "round trip time"). \* Jitter: The variability in the delay between your computer and the testing server.

The results of my tests were as follows:

#### WUBI? What the Heck Is A WUBI? By Jim McKnight

This article has been obtained from APCUG with the author's permission for publication by APCUG member groups; all other uses require the permission of the author (see e-mail address below).

The Windows-based Ubuntu Installer (WUBI) is a program that allows you to install and remove Ubuntu-Linux from within Microsoft Windows (98, 2000, XP, Vista, or Windows 7). WUBI automatically creates a dual boot option that lets a Microsoft Windows user try Ubuntu without risking any data loss due to disk formatting or partitioning. Normally, installing Ubuntu or any version of Linux on a system that is also running Windows Is intimidating and very risky. Total failure to boot Windows is a common result.

WUBI to the rescue: The WUBI installer is now included on every Ubuntu Live CD and easily installs Ubuntu INSIDE of windows (all versions), and in the same partition (drive letter) as Windows if you like. The install process is like any other program installed in Windows. Installing this way is sooooo easy. Also, when you want to remove Ubuntu, you just go to Add/Remove Programs and remove it like any other program running under Windows.

Dual-boot: After the installation, a new (dual) boot option screen appears right after power up, allowing you to select whether you want to run either Windows standalone or Ubuntu standalone. Wow, what a great way to play with Linux/Ubuntu without the hassle of partitioning the hard drive and dealing with those messy dual-boot managers like GRUB or GAG. Yuck (Yes, those are real acronyms. Not the Yuck. It just means yuck).

To start the process, you need an Ubuntu Live (Install) CD that you or a friend has downloaded and burned. You can also go to the Ubuntu website and have them mail you a free CD (10 weeks).

To install Ubuntu using WUBI, just insert the "Ubuntu Install CD" while Windows is running. Do not boot the CD. The CD should start. If not, go to My Computer, open the CD and click on wubi.exe. When you see the opening window, simply select "Install Inside Windows." After that, you answer a few questions about what drive letter, and how much drive space you want to allow for Ubuntu.

That's it!

I have tried this under XP and Windows 7 and it is flawless.

#### NOTES:

- Hibernation is not supported when installing Ubuntu via WUBI (for either Windows or Ubuntu).

#### Inserting the Total Number of Pages in Your Document By Sharon Parq Associates

It is not unusual to put a page number in your headers or footers, if you choose to use headers and footers with your document. You can also, however, insert a field that indicates the total number of pages in a document. This can be used in a header or footer or directly within the text of your document. To insert the total number of pages in your document, follow these steps if you are using a version of Word prior to Word 2007:

1. Position the insertion point where you want the total number of pages to appear.

2. Choose Field from the Insert menu. You will see the Field dialog box.

3. In the Categories list, choose Document Information.

4. In the Fields Names list, choose NumPages.

Click on OK.

The process of inserting a field is a bit different in Word 2007. Follow these steps:


